Call to Order: The Board of Directors Meeting was called to order by President Brian Solan at 6:36 p.m.

**Minutes:** Approval of the January 25, 2015 Board Meeting minutes, held via telephone conference call. **Motion:** It was moved and seconded that the January 25, 2015 minutes are approved, as written. Motion passed.

## Informational:

- Tom Carlson recently discussed a potential transplant location with Scott Hemmer and Cory Loecker of MT FWP. Tom is to update the Board at the upcoming fundraiser in Helena.
- GIA 15-1, a proposal to contribute funding to fencing in the Gardner area was discussed. This
  appears to be a long-term project with discussion deferred to such time as more information is
  forthcoming.
- GIA 15-2, a proposal to fund a review of historical sheep records by University of Montana researchers has been received. Justin Spring is to outline in detail at the next Board meeting.
- Brian Solan confirmed that WSF has withdrawn support for the proposed closure/revised mission proposal for the USSES. More information is expected from Kevin Hurley of WSF later.
- The Pittman Robertson annual report was provided to the Board for review.
- The annual Montana Bighorn Sheep population estimate grid was presented, with more discussion at the next Board meeting.
- MT WSF will fund a plaque for presentation at the Montana Taxidermists Association's annual convention in March.
