# President's Message

**2018 was a challenging year for me as there was a major road construction project on all four sides of my business. I like to think that with each challenge an opportunity presents itself. While the road construction brought decreases in sales and major annoyance daily, it did bring many opportunities for growth. I also like to think the good Lord rewarded my patience with the situation as I drew a moose tag in area 250!**

Area 250 is the West Fork of the Bitterroot River south of Darby. Only one moose tag is given in the area each year, so I was pretty excited and humbled to draw the tag. It was a great adventure as I put in nearly 30 days scouting and hunting with my father-in-law. He was a trooper as I made him walk a couple of hundred miles, ride over 100 miles on horseback, and we spent over 2000 miles in the truck searching relentlessly for a moose. We found one spike on opening day, so I was pretty sure we'd find a mature bull no problem. I was wrong. It took many dedicated days of covering the same ground over and over as well as venturing into new territories. I was ready to call it quits on the last day and told my father-in-law I was done and needed to dedicate myself back to work. We were blessed to find a 42" mature bull early on October 14th. It was also a blessing that my father-in-law was able to go back to his cabin nearly 10 miles away and get his two sons to come and help. That was the greatest blessing - as my two brothers-in-law made quick work of packing out all of the moose with a sled. Dealing with the challenges, drawing the tag and bagging the moose taught me that opportunity truly does come when challenges present themselves. I wanted to give up many times, but I'm glad I didn't.

That brings me back to our mission to put and keep wild sheep on the mountain. Even though the progress seems to come at a glacial pace, we must stay the course to achieve conservation success for this marvelous species. While we were scouting for moose, we were able to view three different wild sheep herds in the area. All of the 250 wild sheep are doing well. One of the herds spends most of its time in the Selway Bitterroot Wilderness. It was so rejuvenating to be able to watch the young lambs play on the cliffs. As you will read later in this newsletter, Montana Wild Sheep Foundation (MTWSF) was able to fund a sheep capture and study in area 250 (West Fork). Area 250 hasn't experienced a wild sheep die off, and the hope is to learn why. Are those sheep tougher? They do like to hang out on the road, so we know they are not skittish! Are the minerals and pH of the soil in the area making the wild sheep healthier and more able to ward off disease? We don't know, but hopefully, some of the data gathered during the study will give us some clues to help perpetuate area 250 wild sheep as well as other wild sheep throughout Montana and beyond.

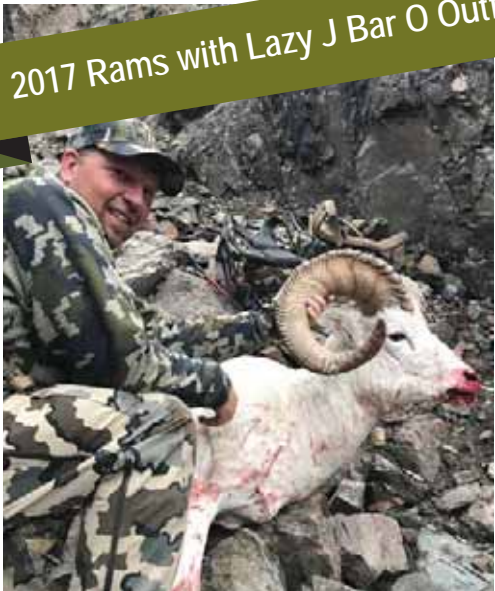

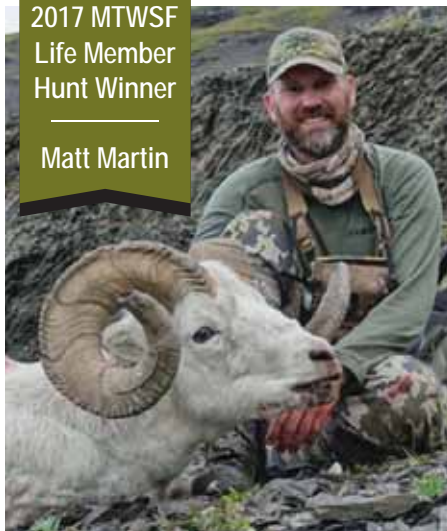

# *The Blessing and the Curse of your Dream Jag*

***Hello, my name is Jim and my sickness "Sheep Fever" started back in the late 90's. I had just come back from a trip to the top of Mt. McKinley (Denali Now). That's when I met Jack Atcheson, Jr. Jack Jr. informed me that I had the making of a sheep hunter "Strong Back, Weak Mind". Referring of course, to why anyone would spend 43 days on Mt. McKinley when there are no sheep there???***

So from there I packed and guided with Jack Jr. for a few years in one of Montana's Unlimited sheep areas. One of the toughest hunts you can go on in the lower 48. I learned a ton from Jack Jr., of course you would have to have a really weak mind not to learn a ton from Jack!!! After Jack Jr. stopped guiding the unlimited area, I decided to go on a solo hunt and killed a legal ram in one of Montana's unlimited area. It was a young ram, but legal! Awesome Experience.

After that I had a bad case of "Sheep Fever". But like most of us, life had a different plan! I got married to a wonderful understanding woman (Bobbi) and we had two wonderful kids (Jimmy and Jessica). My priorities changed from sheep hunter to Dad. I have enjoyed 13 years with my children in the outdoors. I am truly blessed that they both enjoy spending time with their Dad in the outdoors!

That brings me to 2018. It was a June day when I decided to check and see what tags I didn't get. I was on my way to Dillon when I saw I had drawn a sheep tag! I had to pull over and check again. IT WAS TRUE!

After the excitement wore off. The stress of the once in a life time dream tag settled in. The "Sheep Fever" that had been dormant for all those years came back!

From July 1<sup>st</sup> until November 17, 2018 every weekend, except 3, were spent looking for sheep (2 weeks family vacation, 1 week for an elk hunt). Like I said - understanding wife!!! No kitchen passes required.

My hunting partner (my son Jimmy, age 13) and I spent hundreds of hours looking, hiking, 4 wheeling, and glassing. Lots of glassing!

We saw and kept a log of 160-170 different sheep. Lots of young rams, 5 ½ years or younger. Beautiful animals, but young! I had already killed a young ram and was looking for an old ram, Score was not as important as age. We were looking for an old ram.

As the season drug on, the only rams we saw were young, I kept telling myself enjoy it, this maybe the last time you hunt sheep for many years. My young guide Jimmy kept telling me, we will find that old ram Dad.

Well the season was coming to an end and I was wrestling with myself. I didn't know if I could or would pull the trigger on a young ram. But, you can't eat the tag. Hence, the curse of your once in a life time tag. Do you fill the tag even if it is not what you want???

On November 17, 2018 Jimmy and I found an old ram! We knew he was the one from 1 ½ miles away! We drove to within a mile or so of him and two other rams. The wind was wrong, so we went low and out of our way to get the wind advantage! When we topped the hill he was laying there, one ram standing on either side of him. He stood up at 75 yards, I fired a 160 Sierra Boat Tail through both of his lungs. He ran 30 yards and fell over! I didn't know whether to be happy or sad, the hunt was over?

When we walked up on the old ram we noticed he had wounds on his left rear ham and on his back. A couple of wolves had had a go with him in the past few weeks. He had survived the wolf attack, but when we started to chunk him up, he was skin and bones. He would not have made the winter!

He was 8 ½ years old and green scored 181 1/8. He was everything we were looking for in a ram! It was great to take an animal at the end of his life and I think we saved him a slow death this winter!

So the hunt was great, because hunting with your son is a true blessing! Unfortunately I think I cursed him with "Sheep Fever"! Å

# Bylaw Changes

*The last time I bought a new bow, the pro at the bow shop told me he couldn't imagine the equipment progressing much further. My new bow was light years faster than the boat anchor I had been carrying around. I was impressed and agreed that it wasn't possible for bows to get faster or lighter. That was ten years ago, and we were both wrong. I was a fool to underestimate human ingenuity, as today's archery equipment is increasingly faster, lighter, and more forgiving.*

It shouldn't be a surprise that technology is affecting the way the Montana Wild Sheep Foundation does business. At one time, the Board of Directors met mostly over the phone or in person. Fast forward today, we are able to streamline meetings using electronic presentations and video conferencing. Each year there are new opportunities to use the latest technology to improve MTWSF's business process.

Our bylaws were written at time when these electronic opportunities were not available. This last November the Board of Directors amended the bylaws to allow use of new technologies. The amendments allow for electronic conferencing and elections. The Board has also been dealing with issues relating to the timing of the election and nomination of candidates. As such, changes were made to the election deadlines and the language for the number of required candidates was eased.

Technology changes are also planned for this year's banquet. We will be introducing mobile bidding and electronic event management. You can expect much shorter lines when you check out next year!

The Board is excited to embrace new technologies to be more effective in accomplishing our mission to enhance and promote wild sheep. If you have any ideas on how we can keep up with our changing world, we would love to hear from you.

Amendments to the bylaws are presented herein.

## ARTICLE V BOARD OF DIRECTORS

### Section 3. Meetings.

(c) Telephone or Electronic Conference Calls. In the interest of conserving funds and reducing expenditures, or to expedite discussion, obtain approval, or adopt important measures, and otherwise conduct the business affairs of the Foundation, telephone or electronic conference calls of the Board of Directors (or of the Executive Committee) may be scheduled by the President, reasonable notice being given, and regular business may be transacted, so long as a quorum

is present through participation in the telephonic conference. The customary rules of parliamentary procedure shall pertain, except that the regular Order of Business prescribed in Article XIV may be waived and the Secretary shall keep a record of the proceedings as at a regular meeting of the Board.

## ARTICLE VI NOMINATION AND ELECTION OF DIRECTORS

### Section 2. Nomination and Election of Directors.

(b) The Secretary shall give notification by publication in the WILD SHEEP newsletter or by a general or electronic mailing to all members as to the date and



place of such meeting of the Nominating Committee at which nominations for Director will be selected.

(c) Recommendations to the Nominating Committee for nominations must be received by the Chapter no later than the first day of ~~August~~ July. Biographical sketches, not to exceed 250 words in length, shall be submitted along with the recommendation to the Secretary of the Chapter by or for each candidate no later than ~~August~~ July 1. Any willful material misrepresentation contained therein shall invalidate the candidacy, provided that (1) such misrepresentation shall have been first brought to the attention of the Secretary, and (2) the candidate persists in the inclusion of such misrepresentation in the biography by submitting a further statement or reaffirming the trustfulness thereof. In the event of appeal of the decision of the Secretary in any matters concerning a biography, the President shall appoint an ad hoc committee, chaired by the Vice President, to make a final determination.

(d) Not later than ~~September~~ August 1, the Nominating Committee shall select a list of nominees for the Office of Director, which list shall strive to present a list that contains a greater number of candidates than the number of vacancies occurring on the board.

(f) Annual election of Directors shall be conducted by mail or electronic ballot of members. Not later than ~~September~~ August 10, the Secretary shall cause a ~~printed~~ ballot bearing ~~authenticating membership numbers~~ to be mailed or electronically transmitted to each individual or chapter member entitled to vote, directed to his or her or its last physical or electronic address of record with the Chapter; provided, however, that, to be entitled to a ballot, a properly-completed, fully-paid application for membership shall have been received by the Secretary at least thirty-days prior to the mailing or electronic transmission of said ballot.

(g) The ballot shall list thereon the names of all nominees proposed by the Nominating Committee. The order of nominees on the ballot shall be alphabetical. The ballot shall contain blank spaces for "write-in" nominations equal to the number of vacancies to be filled. The final date on or before

which the ballot must be received by the Chapter in order for it to be counted shall be shown clearly on ~~the face~~ of the ballot.

(h) A member desiring to vote shall clearly mark his or her or its ballot for choice of Directors, the member may make the selection from the list of nominees ~~printed~~ presented on the ballot, or in lieu of one or more of such nominees, may write in the names of other members whom the voting member believes eligible to hold the office of Director. In either event, in order for the ballot to be valid, it must not contain a total number of votes greater than the number of Directors to be elected. Having marked the ballot, the member must ~~place and seal~~ mail or electronically submit the ballot. Any ballot received by the Chapter later than ~~September 10~~ August 31 shall be invalid and shall not be opened or counted.

The President shall appoint a teller committee to tabulate ballots and supervise and validate the election.

(i) A ballot shall be invalid if not cast on the official printed or electronic ballot form provided by the Chapter, if not received by the Chapter on or before the prescribed latest date specified on the ballot, if the voter has already voted, if the ballot is not clearly marked or if the ballot contains votes for more candidates than the number of Directors to be elected. However, no ballot shall be invalidated for failure to contain a vote for each of the vacancies to be filled in the election.

## ARTICLE XVII PROHIBITION OF PROXY VOTING

At all meetings of the Board of Directors, Executive Committee, or other committees of the Chapter and meetings, each person entitled to vote shall have a right to cast one vote on each question presented, which vote shall be cast personally and not by proxy. This prohibition shall not be construed to prevent members of the Board of Directors, the Executive Committee or members of other committees of the Chapter from conducting telephone or electronic conferences, so long as a quorum of the body is present and the conditions of Article V, Section 3, are met.

# *Painted Rocks Herd Capture*

***On December 13, 2018, Montana Fish, Wildlife & Parks veterinarians, biologists, and game wardens, along with a contingent of volunteers, captured big-horn sheep in the Painted Rocks herd (Hunting District 250, West Fork) for disease testing and collaring.***





This herd has been of particular interest to biologists and sportsmen for decades. It is one of only a handful of bighorn herds for which a pneumonia outbreak has not been documented; however, the sheep have never been tested for disease exposure. In addition, it has long been uncertain to what degree this herd is connected to nearby herds, including the Nez Perce sheep herd (a native herd that winters in Idaho but spends much of its time in the Nez Perce drainage) and the East Fork herd, the latter of which experienced two pneumonia outbreaks in the last decade.

FWP first attempted to capture these sheep last year using a drop net, but after two weeks of pre-baiting the net site with no success, the capture was abandoned. This year, FWP used Quicksilver Air, a company that specializes in aerial wildlife capture, to net-gun sheep and transport them to a processing site for disease testing and collaring.

Painted Rocks Reservoir, located approximately 21 miles up the West Fork, proved to be a challenging area to capture sheep. The sheep range (primarily west and north of the reservoir) is made up of treacherous cliffs, heavily timbered forest, and large swaths of burned hillside still covered in tall snags. Despite these difficulties, pilot Mark Stott and his crew successfully captured 11 sheep (2 young rams, 8 ewes, and 1 lamb).



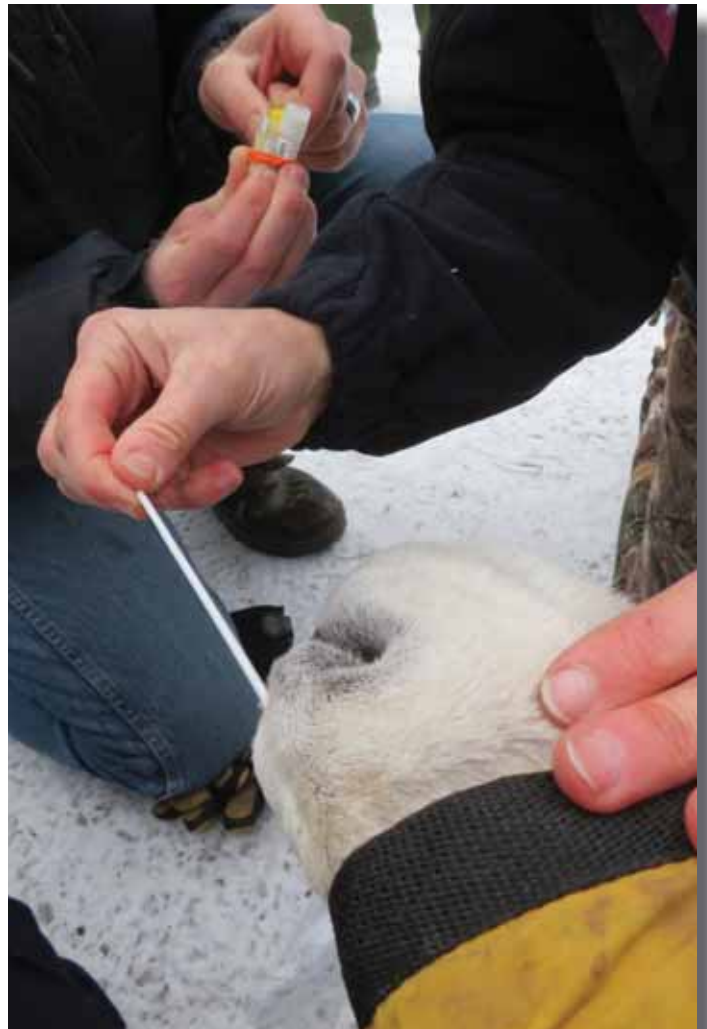

The Montana Chapter of the Wild Sheep Foundation, with a contribution from the local Ravalli County Fish and Wildlife Association, generously donated funds to purchase 8 radio collars (4 for rams, 4 for ewes) to track these sheep and determine their movements throughout the year. Unfortunately, only 3 ewe collars were deployed during the helicopter capture; FWP held back one collar to try to deploy on a ewe from elsewhere around the reservoir (as all 11 sheep came out of the same group). In addition, the ram collars proved to be sized too large for the Painted Rocks rams.

FWP will be modifying these collars to fit the rams, and will work throughout the winter to deploy the remaining collars through ground-darting. These sheep will also be tested for disease exposure.

FWP would like to thank MTWSF, RCFWA, Quicksilver Air, and the many volunteers who showed up on a cold winter day to help monitor and process the captured sheep. None of the sheep (or volunteers) were injured in the process, and while there is still work to do, we hope the information gathered from these efforts will help FWP manage this herd for its continued presence on the landscape. Å





# Investment in Youth Always Pays Off!

**Montana Wild Sheep Foundation (MTWSF) makes a substantial investment in youth each year by helping to found and now sponsor the Youth Conservation and Education Expo (Expo) at the Teller Wildlife Refuge in Corvallis, Montana. The Expo was conceived by dedicated MTWSF Life Member, Tom Powers of Stevensville, Montana. Tom was able to bring together nearly 50 conservation and education groups to put on a free event for youth in the Bitterroot Valley.**

Youth attending the free event are able to experience many conservation and hunting groups while participating in outdoor oriented activities. At each Expo, MTWSF has a part in awarding over 100 scholarships to various hunting and conservation camps throughout Montana.

Marcus Klemp, was one of the first campers to attend the Youth Conservation & Education Expo in 2013. There he won a scholarship to attend one of the conservation and hunting camps later that summer. Fast forward five (5) years from that first Expo and Marcus was given a scholarship to attend a shooting sports day camp in the summer of 2018 at Whittecar Shooting Range in Hamilton, Montana. MTWSF donated all of the pistols for the event to be used in perpetuity by area youth. The staff and teachers at the camp noticed Marcus had a real talent for marksmanship and recommended that he participate in the Hellgate Junior Shooting Association. Later in 2018, Marcus attended the Montana Junior Olympic qualifying competition in Bozeman and won two bronze medals in his first statewide competition. He has also been champion at several of the local shooting events in the Missoula area since starting school in the fall of 2018.

MTWSF wants to congratulate Marcus on his hard work and wishes him success in his future endeavors. It is exciting to think about the opportunities all area youth can experience through the MTWSF investment in youth conservation education. Not every child will become a potential Junior Olympian, but every child deserves an opportunity to experience the outdoors and nature!
